

## LICENCE CONDITIONS

- 1 No person under 18 years of age shall be admitted to the premises hereby licensed.
- 2 Except as provided for in sub-paragraphs (a) - (c) below no advertising material, sign, graphic or pictorial display whatsoever referring to the premises or to the goods, articles or services provided therein shall be displayed outside near to or within the premises in such a position or manner as to be visible to any person lawfully using any street, highway, close, yard, court, footpath or place to which the public has access for the time being.
  - (a) The business or trading title of the premises which must have received the prior written approval of the Council may be displayed in letters no more than 6' high.
  - (b) A sign must be displayed over the entrance door stating "NO PERSON UNDER 18 YEARS ADMITTED" in letters no more than 3' high.
  - (c) A sign of no more than 1 square foot in size indicating the opening times of the premises may be displayed on the entrance door.
- 3 The closing hours for the time being in force within the Borough of Stafford shall apply to the premises but under no circumstances shall the premises be open on Christmas Day, Bank Holiday nor on any Sunday irrespective of the hours of opening of any other retail establishments within the Borough.
- 4 All windows doors or other means by which the interior of the premises would otherwise be visible to any person lawfully using any street, highway, close, yard, court, footpath or place to which the public has access for the time being shall be obscured or screened in such a way as to prevent the interior of the premises or any article material or display therein from being visible to any such persons.
- 5 Persons resorting to the premises must not have access to or from any premises used for any other business.
- 6 The written permission of the Borough Council for the conversion of a shop to a cinema or vice versa must be obtained before such conversion is carried out.
- 7
  - (a) For a sex shop - the shop must not be used as a sex cinema and no moving picture, moving display nor recorded sound of any description howsoever produced shall be permitted upon the premises except for the bona fide purpose of demonstration only to a prospective purchaser hirer or borrower of the article in question but not further or otherwise.
  - (b) For a sex cinema - the cinema must not be used as a sex shop and no articles of any kind may be sold or advertised for sale on or near the premises without the prior written permission of the Borough Council.
- 8 The premises shall at all times comply with all the requirements of the Fire Officer.
- 9 No food or refreshments shall be served at the premises save to bona fide members of staff employed upon the premises.
- 10
  - (a) No amusement or gaming machines of any kind shall be installed kept or used at the premises.
  - (b) Save where the premises licensed are a sex cinema or in pursuance of Regulation 7(a) no music of any kind shall be played on the premises.
- 11 In these Regulations the words "sex shop" and "sex cinema" have the meanings ascribed to them in Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982.
